

# John Corradetti

# June 6, 1925 — November 24, 2019

#### Obituary of John Corradetti

Age 94 of Joliet, passed away Sunday, November 24, 2019 at his late residence surrounded by the love of his family.

He is survived by his four loving children: John (Jane) Corradetti, Jr. of New Lenox, June (Thomas) Doughty of Joliet, Jean (Steven) Yates of Shorewood, James (Mary Lee) Corradetti of Joliet. He was a devoted grandfather to his six grandchildren: Stephanie (Dan) Manno, Stacy (Jason) Vitas, Nicole (Edward) Koncel, John R. (Michelle) Corradetti , Kate (Jay) Johnson, Carolyn (Mark) Panici; nine greatgrandchildren, and his brother Raymond Corradetti of Chicago Heights.

Preceded in death by his loving wife of 68 years, Yolanda "Yola" Corradetti; sister Livia Zarlengo of Chicago Heights; parents Emedio and Dominica Corradetti.

John was born in Chicago Heights, IL and attended Bloom Township High School. After graduation, he served in the U.S. Navy during WWII, where he worked as a radio calibrator for the Allied ships in Okinawa. While stationed in Boston for a short time, he met the love of his life, Yolanda.

Upon completion of his service, the newlyweds moved back to Illinois where John continued his education, receiving a Business Administration degree at Illinois State University, and a Master's degree from Northwestern University. After teaching a few years at Joliet Township High School, he taught Business Education at Joliet Junior College and later became Business Department chairman. During his 42 years of teaching, John was proud to have taught over 10,000 students, and he touched the lives of so many more. As a leader at the college, John recognized the need for fair business practices for its faculty. He served as a teachers' union board member and union president for several years, securing health benefits and collective bargaining rights for JJC staff and all public employees.

For his service, John was the recipient of several JJC awards, including the Susan H. Wood Award. After his retirement, he continued to assist his colleagues by forming the JJC Annuitants Association. John worked with others to make sure members understood the financial transition from working to retirement. He worked tirelessly to understand the state's laws dealing with the SURS pension system, and he developed and published a guide instructing surviving faculty spouses pertaining to state pension

# PRESIDENT'S MESSAGE - PAT ASHER

Hello Fellow JJCAA Members,

This issue is dedicated to John Corradetti who passed away on November 24, 2019. John was the first President of JJCAA and served the Association with effort, dignity, and pride.

One issue that remains a challenge is increasing membership in our organization, which is a chapter member of SUAA (State Universities Annuitants'



Association). During this past year, membership in SUAA has dropped by some 300 members. Part of this is due to our aging population. Thus, it is clear that chapters like JJCAA need to increase membership primarily with current employees! In fact, I have asked each officer and delegate to create two strategies for next year to increase membership.

In 2018, we had modest success, adding sixteen (16) new members whose names appeared in the Winter Newsletter of 2018. In 2019, our efforts increased and so did the results. We added thirty-seven (37) members through various activities:

- Appearing at the opening session of Staff Development: Linda Aguilar and Mary Ann Oetter

As well, with each new member, I send this acknowledgement: "The Officers and Delegates of JJCAA are grateful to you for joining our association. We will continue to work hard to protect our pensions and other benefits."

Further, while at the Benefits Fair, I had the opportunity to speak with our President, Dr. Judy Mitchell. She has invited me to the December 18th meeting to speak with her Cabinet of nearly forty (40) members about our association. Linda Aguilar will attend as well!

In addition, I have received tremendous support and cooperation from Judy Connelly, Director of Human Resources!! Without her efforts, my work would be much more difficult!! Many thanks as well to Amanda Quinn and Kristin Mulvey from the Foundation for sponsoring the continental break-fast at the Annual Meeting. The same appreciation goes to Scott Olsen, editor of this publication.

Finally, Senator Pat McGuire is retiring from the General Assembly, having served there since 2012. He was a mighty force in educational endeavors, and the citizens of the 43th District will miss his presence!! Prior to entering politics, he was a superb student at JJC and learned that Aristotle's claim that man was born for citizenship should be taken seriously; he did. In addition, he was an excellent adjunct professor of English 101 and 102 in the English/World Languages Department. I wish him and Laura the best in their futures!!

#### LEGISLATIVE REPORT – PATRICIA NEFF

JJCAA has the designation of having to visit the most number of legislators in any college or university district in the state by way of the district maps. Sometimes, we let a closer institution visit a legislator, but we try our best to get to know those in the JJC district and educate them on the State Universities Annuitants Association (SUAA) and the JJC Annuitants Association Chapter. (JJCAA).



It is with great regret, that one of our best supporters and former JJC teacher, Senator Pat McGuire, will not be seeking reelection and will retire. Pat became the senator of the 43rd district in 2012 and will continue until January of 2021. He taught at JJC for seven years, namely classes ENG 098, 101, and 102, between the Fall of 1997 to the Fall 2005.

Pat McGuire has worked to invest in our community college system by increasing student financial aid, providing capital funding, and protecting retiree benefits.

McGuire often cites how far the state has drifted from its original community college funding paradigm: that 33% of the revenue would come from local property taxpayers, 33% from tuition and fees, and 33% from the state. Declining state funding for public higher education - a decline which hit rock bottom during the two-year budget impasse under former Governor Bruce Rauner - has resulted in a dreadful imbalance. In 2018, 54% of JJC's revenue came from property taxpayers, 36% from tuition and fees, and only 7% from the state. Obviously, this pinches homeowners and students and threatens to impact collective bargaining over retirement provisions.

McGuire chairs the Senate Higher Education Committee, is a member of the Appropriations II Committee which hears higher education budgets, and is a founder of the bipartisan, bicameral Higher Education Working Group. He has worked in all of these capacities to keep Joliet Junior College strong for students, staff, retirees, and District 525 residents.

He shares an office with State Representative John Connor, 85th District, and has endorsed him for senator. John also has teachers in the family and has been a good supporter of us as well.

We wish Pat all the best in retirement, but he is not gone yet so we will be visiting him in the spring, along with other candidates. It will be a busy year, to be sure. More details will follow in the summer newsletter.

# JJCAA SCHOLARSHIP OF \$500.00

Another accomplishment is the creation of an annual JJCAA Scholarship of \$500.00.

Qualifications:

- The applicant is a dependent or spouse of a JJCAA member.
- The applicant has earned twelve (12) credits with a minimum 3.0 GPA. Each scholarship award can be used for tuition, books, and fees.
- The applicant must complete the application process for the JJC Annuitants' Association Annual Scholarship online at the Joliet Junior College web site

The final determination of selecting the scholarship recipient shall be the sole responsibility of appropriate officials of Joliet Junior College.

This year, there were no applications. It will be offered again in the fall of 2020. I urge those who qualify to apply!!!

Dear SUAA Member:

2019 will be remembered in Springfield as one of the most eventful legislative sessions in modern history. We do not exaggerate: lawmakers approved more landmark legislation – from a balanced budget and a major capital program to significant abortion and marijuana legalization – in just one session than usually gets addressed over the course of several years.

We are encouraged for members of the State Universities Annuitants Association for two major reasons: progress after years of gwidlock is welcome, and it did not come at the expense of our membership. We hope you will continue your membership to ensure similar success in future sessions.

Here is how this session affected our currently working and retired community college and university members:

- Budget A \$40 billion state budget is balanced, did not require major tax or fee increases because of an influx in revenue late in the spring, and it makes important investments in higher education that were often absent under the previous administration. One of those ends a 3 percent cap put in place last year that limited the annual salary increases for K-12 and higher education employees that can be applied to your pensions.
  - Higher education receives a 5 percent increase in funding, and \$5 million will be devoted to the Community College Health Insurance Security Fund
- Capital program A \$45 billion, six-year plan will make long-needed investment in our state's
  horizontals (roads, bridges, transit systems) and verticals (schools, universities, hospitals). Our
  community colleges and universities will receive hundreds of millions of dollars for repairing
  leaky roofs, improving classrooms and making other investments on campuses
- Pensions Rest easy that your pension benefits are protected for another legislative session, thanks to the hard work of our SUAA team
  - Despite a proposal from Gov. Pritzker to skip pension payments, the state will make its required pension payment at the certified amounts to all five pension systems under this budget
  - A proposed constitutional amendment to remove the Pension Protection Clause of the Constitution was proposed but never progressed in the Legislature
  - o The state's pension buyout program has been extended to June 2024
  - We will continue working with legislators to address the need for a long-term pension debt solution and to address problems with the Tier 2 and Tier 3 programs

Fair Tax amendment – You and all other Illinoisans will be asked to vote on the Fair Tax
amendment in the November 2020 election, and assuredly bombarded with advertising for and
against the concept between now and then. Gov. Pritzker successfully persuaded legislators to
put the question on the ballot of whether Illinois should switch from a flat income tax system to a
graduated income tax, where those who make more pay a greater percentage of their income in
taxes.

Finally, we are encouraged that Illinois is once again moving forward on major issues. We hope the same vigor that was seen this year, and the can-do attitude shown by dozens of new legislators, will carry over to dealing with pension debt and higher education funding and other major challenges.

We cannot do this alone. Please keep your SUAA membership active in order to stay on top of the latest developments at the Capitol, and to provide us the insight and support we need to be effective for you - for today and tomorrow. Together, we can and will do better!
